HIGHLIGHTS

- The Company submitted the Environmental Impact Assessment submission for development approval
- Public consultation and community engagement ongoing

Black Dragon Gold Corp. (ASX:BDG) ('Black Dragon' or the 'Company') is pleased to provide the following activities report that outlines the progress made and reported during the third quarter of 2021. The Company submitted the Environmental Impact Assessment ("EIA") and continues to operate at a functional level while keeping administrative and exploration costs to a minimum.

ENVIRONMENTAL IMPACT ASSESSMENT PROCESS FOR SALAVE PROJECT

The third quarter of 2021 has seen progress on the EIA, Exploraciones Mineras del Cantabrico ("EMC") submitted the Mine & Restoration Plan and its EIA to the Principality of Asturias' Ministry of Mines on 28 July 2021. This precedes the process of review by the Mining and Environmental Ministries and was followed by a month-long period of public consultation, after which EMC will have the opportunity to address any comments.

In the meantime, EMC has been holding meetings with the community and local associations to manage expectations, address concerns and explain the project in detail. This community engagement will continue and become more frequent as permitting develops.

RESIGNATION OF RICHARD MONTI

On 11 August 2021, Mr Richard Monti resigned from the Board of Black Dragon.

ABOUT BLACK DRAGON GOLD

Black Dragon Gold "BDG" is the 100% owner of one of the largest undeveloped gold projects in Europe, the Salave project. Salave is situated in the North of Spain in the province of Asturias. The Salave project has an updated Measured Mineral Resource of 1.03 million tonnes grading 5.59 g/t Au, containing 0.19 million ounces of gold; an Indicated Mineral Resource of 7.18 million tonnes grading 4.43 g/t Au, containing 1.02 million ounces of gold, plus Inferred Resources totalling 3.12 million tonnes grading 3.47 g/t Au, containing 348,000 ounces of gold.

A full technical report summarising the Mineral Resource estimate completed by CSA Global is available on the company's web site (www.blackdragongold.com) and posted on SEDAR. In addition to the current Mineral Resource, historical exploration work suggests there is the potential for additional mineralisation within Black Dragon's landholdings.

COMPETENT PERSON STATEMENTS

The information in this announcement that relates to exploration results for the Salave Project is based on and fairly represents information and supporting documentation reviewed and approved by Douglas Turnbull, P.Geo. Mr. Turnbull is a consultant to Black Dragon Gold and a Qualified Professional Geoscientist recognized by the Engineers and Geoscientists British Columbia ("EGBC"), a recognized professional organization for the purposes of the JORC code. Mr. Turnbull has provided his prior written consent as to the form and context in which the exploration results and supporting information are presented in this announcement.
